JOB MATCHING - TERMS & CONDITIONS

1. Jobortunity Hi5 Job Matching offers:

- All candidates presented are former graduates of Jobortunity who have the right skills and attitude for the job vacancy.
- Graduates with some experience (less than 2 years of work experience) and graduates with 2 6 years of experience.
- Arrangement of job interviews between the candidates and the companies at any convenient location.
- In case of a mismatch caused by proven non-Hi5 behavior of the graduate during probation time, we offer replacement without extra charge.
- Candidates' identity is checked and Jobortunity possesses copies of official documents.

2. Jobortunity expects from companies:

- To agree upon these terms and conditions and the confirmation of Job Matching before matching is started by signing the documents.
- Not to contact the candidates directly during the Job Matching process.
- A work environment according to the Hi5 criteria*
- To communicate with Jobortunity in case the graduate(s) is not performing well in the first 3 months of probation time or is fired.
- To ensure that necessary contributions are settled (without deduction) before placement of the graduate(s).
- To pay graduate(s) salaries in accordance with the Tanzanian Labor laws (minimum wage is TZS 175,000).

3. Company Contribution:

- Graduates with less than 2 years of work experience, will attract a one-time fee of TZS 150,000.
- Graduates with more than 2 years of work experience, will attract a one-time fee of **12.5% of the full-time** gross salary per year.
- The contribution includes transport costs for the candidate(s) and responsible person in Jobortunity within Arusha and additional services such as communication costs.
- All costs, whether in or out of court, including the costs of legal assistance that Jobortunity must make due to non- compliance with the debtor's payment obligations are born by the client. Tax changes by laws and regulations will be passed on to the company as from the date of such changes.

4. Liability:

- Subject to provisions of mandatory law and in compliance with the general standards of fairness, Jobortunity is not obliged to pay any compensation for damage of any kind, directly or indirectly, to the graduates or to business or persons or the client, which damage arises because of:
- The posting of graduates to the client, even if it appears that the graduate does not appear to meet the requirements imposed by him.
- Unilateral termination of the employment contract by the graduate.
